# Membership Terms and Conditions

## **1 General**

- 1.1 Memberships are strictly non-transferable.
- 1.2 All members will be provided with a membership card. Every time you visit the Centre you must get your card swiped at Reception and collect a ticket for the activity of your choice. Failure to do so will result in non-member rates being charged. This ticket must then be presented to the appropriate member of staff. Failure to do so could result in entry being refused.
- 1.3 Replacement of lost cards will incur the holder an administration charge of £2.50
- 1.4 Cancellation of any booked activity requires six hours cancellation notice to avoid being charged the cost of the activity.
- 1.5 Should your address or any of your personal details change during the term of your membership you must inform the Centre.
- 1.6 Family memberships only remain valid while the juniors are aged under 16 years. Once a junior becomes an adult the membership will be altered or void.
- 1.7 The Discounted Annual Membership is applicable to students aged 16+ years in full time education or individuals in receipt of Disabled Benefit, Incapacity Benefit, Income Support, Job Seekers Allowance or Housing Benefit. Proof of eligibility will be required to join this membership.
- 1.8 Access to all facilities and activities will be as per the opening times and programmes listed in our Centre leaflets.
- 1.9 The Centre reserves the right to amend or cancel its activity programme.
- 1.10 The Centre reserves the right to partially or completely close some of its facilities during times of maintenance. In such situations due notice will always be given.
- 1.11 All personal information will be kept on file at Bridport Leisure Centre. This information will be kept secure only accessible by employees. Should you wish to view your personal information, you can do so at any time by requesting so at Reception

## **2 Price for Life**

- 2.1 The Price For Life Membership is specific to the individual although transfer of membership is permissible if agreed by the Membership Coordinator. Membership payments must be continuous.
- 2.2 The booking of facilities is always subject to availability and can never be guaranteed.
- 2.3 Facilities booked must relate to casual use and are therefore not eligible for club or block bookings.
- 2.4 Upon joining the Price For Life Membership you agree to pay Leisure Finance monthly instalments by standing order of which the first payment will be due one month after the date of this agreement and subsequent payments on the same day of each succeeding month. You agree that your membership will be for an initial period of 12 months and then shall automatically continue on a month-by-month basis until terminated by you with 30 days written notice of cancellation to Leisure Finance.
- 2.5 Non-payment of monthly fees will automatically render your membership card invalid.
- 2.6 Should extraordinary circumstances arise that require the cancellation of your Price For Life membership within the initial 12 months i.e. illness or pregnancy, proof of these circumstances will be required and a cancellation administration fee will be charged.
- 2.7 The Centre reserves the sole right to suspend or cancel any membership for failing to adhere to the terms and conditions.
